CANDIDATES FOR PRESIDENT-ELECT (2)

**Garrett Eggers, PharmD, MS | Associate Chief Pharmacy Officer
Cleveland Clinic**

Garrett currently serves as the Associate Chief Pharmacy Officer for Ohio regional pharmacy services at the Cleveland Clinic. In his current role, Garrett works to drive safety and quality in patient care through advancing the use of technology and robotics in sterile compounding, developing pharmacy clinical services leveraging the use of consult agreements, and supporting health-system initiatives to ensure USP 797 compliance. Garrett began his pharmacy leadership journey after graduating with his PharmD from the University of Wisconsin, where he then went on to pursue an HSPAL residency at UPMC and obtain his master's degree from the University of Pittsburgh. He then joined the Cleveland Clinic as a manager of sterile products. Over his 12 plus years at Cleveland Clinic, Garrett has held various leadership positions, including overseeing the heart and vascular institute pharmacy services, and serving as the director of pharmacy at Cleveland Clinic South Pointe Hospital.
